IV. Open issues

a. 2018-09-05-1

- b) The idea of a second meeting, held in the spring to allow for nominations and elections for the next season was highlighted. This will allow more time for transition and succession. It was suggested by membership to call for nominations weeks prior to meeting so members can better consider options. Executive will discuss at next executive meeting.
- c) Jim Merrick announced that an effort is under way to set up an association proper within Zone 2 (Big Country), areas surrounding Calgary. Dawn Mosondz will be leading this effort. Officials living in the Zone 2 area are asked to register in that zone. More details will be forthcoming.

- d) Discussion about match assignments. Concerns are:
 - Same officials taking matches at the same location for the whole season.
 - Small group of officials taking majority of matches.

Sherri Weed will consider the concerns and take them into consideration when assigning matches.
